Yr agwedd bwysicaf ar adolygiad yw archwilio'r hyn sydd wedi gweithio'n dda, unrhyw rwystrau i gyflawni canlyniadau llesiant personol, pryderon a sut i fynd i'r afael â'r rhain wrth symud ymlaen gyda chyfrifoldeb a rennir.

English

Evaluation also applies to us as workers- how near or far have we been able to understand/manage the risks presented in any given situation . This is an opportunity to review the assessment- does the current information change the outcome of the assessment? etc

working together – co production enables us to share if we have go something wrong too. The most important aspect of a review is to explore what has worked well, any barriers to achieving personal wellbeing outcomes, worries and how to address these moving forward with a shared responsibility.

Share some questions to help students consider the importance of the individual being involved. referring to the person they are thinking of, if we ask that person on a scale of 0 - 10 where 10 is I totally understand my care plan, what the roles and responsibilities of myself and others are and how I am going to evaluate the effectiveness of my plan and 0 is I have not got a clue? where would you rate it today? what places you at that number ?

what places them at that number?

what needs to happen to get them to a 10?

ask students to think of a child or adult they are currently involved with and to make notes following each of the points we will be working through

work through each section of the slide

I'm in control- how do you ensure the individual is in control over their support. Consider barriers e.g capacity, age, disability etc.

reinforce the importance of seeing any times that the plan is not meeting the assessed need as an opportunity to develop a deeper understanding of the person's situation, what was getting in the way of the need being met, and how can you develop a plan together than has a provision for managing future challenges.

What methods do you use to ensure active participation?

Authorised person- connect this to the Unit re legislation

Persons with PR-Children Act 1989. Ask students to consider how they involve absent parents- difficult to reach parents with PR?


